Dear Mr. Mandalas,

This is a synopsis of the Labor/Management Resolution Committee meeting that was held on various dates between March and June, 2019 pursuant to Article 2 (C) and Article 29, Section 2 (D) and Article 30, Section 2 (C) of the April 1, 2002 revised: August 4, 2014 Collective Bargaining Agreement.

- 1) The Parties need to discuss the discipline policy and address any questions or concerns associated therewith.

Resolution – The Organization disagrees with the Carrier assessing Level 2 discipline of fifteen (15) days actual suspension for a missed call. The Carrier's position is that the discipline policy is not negotiable. The Carrier is looking at some possible adjustments to the current "At Risk" testing procedures and making some of the critical switching failures go to investigation. This is not final yet.

- 2) The Parties need to discuss the use of engineers that are not being called as per the calling procedures.

Resolution – The Carrier stated that with more extra engineers available, they will attempt to get more engineers qualified to more places to prevent

calling procedure violations. Also, there was a discussion concerning out-of-cycle use and the different calling procedures in Article 11(D).

- 3) The Parties need to discuss the OJT positions and define and agree upon the scope of the position.

Resolution - The Carrier will notify the BLET General Chairman when new classes for engineer trainees begin and who will be in them. The Carrier understands the necessity to work with the BLET Local Chairmen to designate engineer trainers. In addition, the Carrier wants to expand engineer trainee "Boot Camps" beyond the trial in the Stevens Point area.

- 4) The Parties need to discuss the System Bulletin Notice #39 specifically the required authorization regarding the disclosure and authorization of background investigation for employment purposes.

Resolution – This issue has been previously discussed and resolved.

- 5) The Parties need discuss the misuse of crews between the Fond du Lac and Chicago corridors that lead to crew shortages and concerns for both terminals.

Resolution - General Manger Albritton will reiterate this issue with the proper managers.

- 6) The Parties need to discuss the application of Article 14 (B).

Resolution – The Carrier will establish a code difference between engineer trainees and engineers who are familiarizing for the purpose of expense reimbursement and explain to payroll department.

- 7) The Parties need to discuss Article 7 Section 1 (B).

Resolution - When more than one Engineer is hired on the same date from sources outside the Company, the lottery system for ranking their seniority order will be applied by using the last 4 digits of their SSN. The engineer with the highest last 4 digits of their SSN will be ranked 1st and the engineer with the lowest last 4 digits of their SSN number will be ranked last.

- 8) The Parties need to discuss Article 24.

Resolution - The Carrier's position is that physical examinations is a condition of employment and that Engineers should have them done on their rest days, with exception of those who have weekends off, as medical examinations cannot be scheduled during weekend, and are required to miss work due to not being able to make an appointment. The Organization will

continue to file claims and progress this issue to Arbitration until this issue is resolved. Discussions were had of potentially scheduling physical examinations scheduled while the engineer is attending recertification class.

- 9) The Parties need to discuss crews tying up at Burlington.

Resolution – General Managers Bistis and Albritton will address this issue with the proper managers to minimize tying crews up at Burlington.

- 10) The Parties need to discuss the seniority protest of Engineer Scott Nelson (Article 7 (2)(B)).

Resolution - The Parties declined the Claimant's protest.

- 11) The Parties need to discuss the seniority protest of Engineer Chad Tucker (Article 7 (2)(B)).

Resolution - The Parties declined the Claimant's protest.

- 12) The Parties need to discuss the seniority protest of Engineer Michael Krig (Article 7 (2)(B)).

Resolution - The Parties declined the Claimant's protest.

Other issues discussed but not listed on the LMRC agenda are as follows:

Per CATS Broadcast Bulletin, Crews tying up in Chicago are to go to the Joliet hotel for lodging unless otherwise instructed differently by the RTC or the Chief prior to getting off their train. Crews have lately been redirected differently to other hotels by cab drivers rather than RTCs.

Resolution - General Manger Albritton will reiterate this issue with the proper managers as crews are to comply with the CATS Broadcast Bulletin.

The Organization was told that when Fond du Lac crews go on duty at the hotel to relieve trains online they would have all required paperwork for the entire northbound trip. This has not been happening as crews arrive to the train and not having all of the required paperwork.

Resolution - General Manger Albritton will reiterate this issue with the proper managers to ensure that crews will have all required paperwork for the entire northbound trip when relieving trains online.

The claims cited herein are submitted pursuant to the specificities contained in Article 29 of the CBA. The Committee is of the position that the claims are with support under the CBA. The grievances are valid and should be allowed.

The Organization would like to discuss the removal or adjustment of discipline for the following Claimants:

- 1) The Organization would like to address the excessive discipline assessed to Claimant Mark Brown (WC-BLET-2018-00053). The Claimant was assessed a sixty (60) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

- 2) The Organization would like to address the excessive discipline assessed to Claimant William McLaughlin (WC-BLET-2018-00056). The Claimant was assessed a thirty (30) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

- 3) The Organization would like to address the excessive discipline assessed to Claimant Jeffrey Latch (WC-BLET-2018-00057). The Claimant was assessed a ten (10) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company is agreeable to remove all discipline regarding this incident from the Claimant's work history and compensate Claimant for eighty (80) hours, including paying the Claimant for time spent attending the investigation. BLET accepted this as full and final settlement of the matter.

- 4) The Organization would like to address the excessive discipline assessed to Claimant John Borst (WC-BLET-2018-00159). The Claimant was assessed a ten (10) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

- 5) The Organization would like to address the excessive discipline assessed to Claimant James Warner (WC-BLET-2018-00190). The Claimant was assessed a fifteen (15) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

- 6) The Organization would like to address the excessive discipline assessed to Claimant Carl Schuler (WC-BLET-2018-00191). The Claimant was assessed a fifteen (15) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company is agreeable to remove all discipline regarding this incident from the Claimant's work history and compensate Claimant for one hundred fifteen (115) hours, including paying the Claimant for time spent attending the investigation. BLET accepted this as full and final settlement of the matter.

- 7) The Organization would like to address the excessive discipline assessed to Claimant Brady Gillies (WC-BLET-2018-00199). The Claimant was assessed a fifteen (15) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

- 8) The Organization would like to address the excessive discipline assessed to Claimant Wayne Brown Jr. (WC-BLET-2018-00200). The Claimant was assessed a thirty (30) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

- 9) The Organization would like to address the excessive discipline assessed to Claimant Darrell McBride (WC-BLET-2018-00327). The Claimant was assessed a fifteen (15) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

- 10) The Organization would like to address the excessive discipline assessed to Claimant Michael Johnson (WC-BLET-2018-00328). The Claimant was assessed a fifteen (15) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

- 11) The Organization would like to address the excessive discipline assessed to Claimant Jesse Kilty (WC-BLET-2018-00372). The Claimant was assessed a fifteen (15) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

- 12) The Organization would like to address the excessive discipline assessed to Claimant Fabian Cook (WC-BLET-2018-00378). The Claimant was assessed a fifteen (15) day actual suspension from service. The Organization requests all mention of the discipline be expunged from the Claimant's record and that he be compensated for all lost time, including the time spent attending the investigation, as well as pay for all work related benefits and seniority vacation rights unimpaired as a result of the assessed discipline is requested.

Resolution: The Company further declined the Claimant's discipline appeal. The Organization will pursue this discipline in accordance of Article 30, Section 2 (D).

The Parties agreed to a tentative date of October 2019 for the next LMRC meeting
